



eCornerstone Application Update

for February 6, 2006 Deployment

GENERAL INFORMATION

- General changes to the application are organized according to the eCornerstone menu, followed by changes specific to each program.
- The **eCornerstone Reference Manual** has been updated with all modifications and enhancements outlined in this document. The Reference Manual can be found by selecting "Help" from the menu, or selecting the "Reference Manual" link under the User Help section on the Home Page.

HOME MENU

- **To Do Messages have been corrected** for action steps that have been reviewed and/or have a quarterly review frequency. Previously, To Do Messages indicated the incorrect due date under these circumstances.

PARTICIPANT MENU

- System modifications have resulted in the addition of a **Medicaid RIN sub-menu**. The submenu consists of the following options:
 - **RIN History:** The RIN History page provides the participant's name, their RIN, and the participant's case number, programs, program status dates and current status in each program.
 - **RIN Search:** The Search for RIN page provides mechanisms for searching for a RIN by entering the RIN or by entering the name. To search by RIN, select the "Search by RIN" radio button, type the RIN and select "Search". To search by name, select the "Search by name" radio button and type the individual's last name in the "Last

- Name" field and the individual's first name in the "First Name" field and select the "Search" button. The RIN Selection page is displayed and lists participant(s) matching the search criteria.
- **RIN Delete:** The new Delete RIN page displays the participant's name and RIN. To delete the RIN, select "Delete".

- System modifications on the **Available Reports page now allow rollup offices to view reports from agencies below them.** Rollup offices will **not** be able to view the protected reports belonging to agencies below them.

TEEN REACH

- The eCornerstone system has been modified to allow a **new site to be selected for a currently enrolled participant on the Program Enrollment screen.** Previously, the system would not allow a site to be changed if that site's begin date was later than the participant's enrollment start date.
- **The Academic Progress page has been modified** so when editing an existing academic progress record, a different school may now be selected, if necessary, from the drop down list of predefined schools.
